

- Implement and promote the use of a Cheshire-wide exploitation tool which is currently being piloted
- Pilot a bespoke exploitation awareness raising programme for young people in Cheshire West and Chester centre based youth provision
- Consider whether training could be provided in primary schools with 8,9,10 year olds
- To support the production of a child sexual exploitation (CSE) plan following the CSE peer review. Ensure ratification by the Local Safeguarding Children Board
- To request a review of the CSE Operational Group
- To establish an annual conference for elected members and governance champions from statutory partners to share data and

information relating to CSE and CCE across the borough

- Establish a data reporting dashboard across the partnership for CSE/CCE referrals. Report this quarterly to the Community Safety Partnership and then through all statutory partner governance arrangements
- Ensure there is appropriate reporting to the Health and Wellbeing Board and the Cheshire Protecting Vulnerable People Board
